ISSUE UNDER SECTION 708A(5)(e)

New Issue of Shares: Notice pursuant to s708A of the Corporations Act (the Act)

On 14 August 2015, Stonewall Resources Limited (the **Company**) issued 79,520,240 fully paid ordinary shares in the Company in consideration for the completion of the Company's acquisition of Stonewall Mining Proprietary Limited (**Mining**).

These shares were issued in accordance with shareholder approval granted at the Company's General Meeting held on 4 August 2015 and pursuant to the exercise of a Put & Call Option Agreement with South African based shareholders of Mining.


The securities are part of a class of securities quoted on the Australian Stock Exchange Limited (**ASX**).
